The League of Women Voters (LWV) is a national nonpartisan organization whose purpose is to promote political responsibility through the informed and active participation of citizens in government. The LWV does not endorse or oppose candidates or parties, but it does work to obtain and distribute information to the public on candidates and their views.

We are preparing to publish the nonpartisan [LWVCC VOTER GUIDE](#) for the **November 6th**, 2018 General Election. The Voter Guide will be published and distributed by the Daily Mining Gazette on **October 16th**.

The enclosed questionnaire is being sent to candidates who have qualified to appear on the ballot or are publicly committed write-in candidates. There are word limits, so please be as brief as possible. Complete sentences are unnecessary: the use of one or two-word phrases is acceptable. Our policy is not to edit responses except to cut the reply at the word limit, followed by an ellipsis (...). Although the word limit is somewhat confining, please keep in mind that all candidates have the same limits and the same opportunity to reach the voters.

E-mail your response to cclwvmi@gmail.com in the Subject Line ADD: "Candidate Response 2018", or mail to LWVCC, P.O. Box 815, Houghton, MI 49931. If you are sending an email, be sure to include all the info on the questionnaire in your email message. Once you email your response, you will receive a response stating we have received your response and thank you. Provision of candidate information by e-mail implies permission to publish.

Enclosed is a copy of the questionnaire. If you decide to participate, please return it to the LWVCC and make a copy for your own files. Your reply must be e-mailed or postmarked by the deadline no later than midnight, Tuesday, **September 25**, 2018, so please act promptly.

If we do not receive your reply by the deadline and you are in an uncontested race, then we may not publish your race. If you do not reply and are in a contested race, then we will print "Did not respond".
