ABSENTEE BALLOTS
You may vote by absentee ballot if you:
• are 60 years or older
• will be or expect to be out of town on election day
• are physically unable to go to the polls
• are unable to attend due to religious tenets
• are an election inspector in another district
• are in jail awaiting arraignment or trial.
Apply for an absentee ballot at your school, village, city, or township office well before an election.
