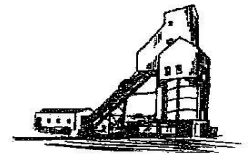

'Net neutrality (also network neutrality or Internet neutrality) is the principle that Internet service providers and governments should treat all data on the Internet equally, not discriminating or charging differentially by user, content, site, platform, application, type of attached equipment, and modes of communication.' **Minutes - Annual Meeting of Members

Call to Order:

The meeting was called to order by second VP Mary Jane Hatton at 11:08a.m.

Quorum: Secretary Fink, confirmed that a quorum of the membership was present.

Appointment of Parliamentarian:

V.P. Hatton appointed Lisa Dunnebacke to serve as Parliamentarian for the meeting.

Appointment of Committee to Approve 2014

Minutes :

V.P. Hatton appointed Sherry Zoars, Bradof and Flagstadt as the Committee to review and approve the Minutes from the 2014 Annual Meeting. The Committee to review the Minutes of the 2013 Annual Meeting of Membership had read and approved the Minutes and those were previously reviewed and accepted by the board and published in the Voter.

Treasurer's Report:

The Treasurer's report was presented by Mary Marchaterre. The report was accepted and placed on file.

Financial Reviewer's Report:

Stacey Froese conducted a review and submitted her report (found at the bottom of the budget page) that the financial records for the fiscal year 2013 -2014 were in good order.

Budget Committee Report:

The Budget Committee, represented by Marchaterre, presented its recommended Budget for fiscal year 2014-2015. It was moved by Tony Zoars and seconded by Faith Morrison that the proposed Budget be adopted. Motioned passed.

Proposed amendments to the by-laws

Proposed amendments to articles 3; 4; 5; 9 and 10 are printed in the program booklet. Ellen Varney moved and Flagstadt seconded the adoption of the amendments as proposed. Motion passed.

Adoption of Program:

It was moved by Marchaterre and seconded by Kreher that the LWVCC current positions as printed in the meeting booklet on Houghton County Government, Education, Keweenaw Waterway, Fluoridation, Land Use and Election Procedures and Houghton County Jail Facility be retained. Motion passed

Other Business

There will be a meeting in May on Internet Neutrality presented by Sloane.

The national convention will be in Dallas in June. Any member interested in attending as our voting delegate should let a board member know by May 1st. Marchaterre reminds members to speak to a board member about any candidate forum they believe we should conduct in the upcoming election season.

Directions to the Board from the Membership:

1. Dunnebacke encourages use of the Chamber of Commerce bulk mailing permit to contain costs.

3. Ruthann Ruehr wants a note sent to Dale Yeo acknowledging her contributions.
4. Dunnebacke suggests Education as a focus for educational activities in the fall before the election. She is concerned about several new laws enacted in MI creating rapid changes in education in the last two years. She notes that our local position may need new language.

5. Morrison requests that minutes reflect support among those present for the concerns raised by Dunnebacke.
6. Bradof suggests Healthcare will continue to need attention in the next program year. In particular a program to call attention to consumers getting cost information for what they will be billed for tests, procedures, etc. is needed. We could ask LWVUS to address this situation.
7. Varney remarks that she is pleased with hearing of U.P. legislators acting collaboratively regarding issues impacting the UP.

Highlights from Annual Meeting Speaker Presentation

The well received speaker at the annual meeting of the Copper Country League of Women Voters, Marilyn Clark, CEO of the MTEC Smart Zone, included in her comments many interesting facts. Houghton county is one of three rural counties to have population growth even while MI was the only state to lose population in the last census. Fifty-four percent of MTU students would like to stay in the community if work were available. The Smart Zone goal is to expand the job base, especially technical jobs, available in the area. Clark has seen an increase in good will between the city governments of Houghton and Hancock, which together with MTU, are advisors to the Smart Zone.

The Smart Zone is looking for job creators with the potential for rapid growth. There are many high tech companies here now. Most of their clients are not here but are, in fact, global. Our students are equipped with good skills for cross communication, using phone, email, internet programs. Our Smart Zone is second of the 18 in the state in creating start-ups. It provides structure for start ups, most of which are self-funded, boot-strap operations. About one-third have so far failed. They are challenged to find out early if their idea will succeed.

The MTEC Smart Zone is starting, or "spinning off" a new Smart Zone in Marquette. Houghton is one of three out of the eighteen in the state allowed to do this. This new funding and initiative will allow the MTEC Zone to be extended for another fifteen years. Had it not been awarded, the project would end in 2017. The Marquette Zone is expected to add "thing" start ups to the "idea" start ups that are typical of the Houghton Smart Zone. Marquette benefits from access to MTU expertise.
